## THINGS TO DO BEFORE YOUR ARRIVAL IN LAUSANNE:

Prior to departure	
Step 1	At least 3 months before leaving your country of residence
	Apply for a visa/ residence permit at the Swiss embassy or consulate in your country <u>for</u> <u>non-EU/EFTA nationals</u>
Step 2	At any time before your departure
	Collect important originals documents translated into French, English, German or Italian) <i>(if you are staying more than 90 days)</i> :
	- Your birth certificate
	- Your marriage certificate (if you're married)
Step 3	As soon as you know your arrival date
	Find accommodation or temporary housing solution
Step 4	Before leaving
	Clarify childcare solutions and/or school system for your kids
Step 5	Before leaving
	Inquire about health insurance which is mandatory in Switzerland

## THINGS TO DO AFTER YOUR ARRIVAL IN LAUSANNE:

Upon your arrival	
Step 1	During the first week (if you are staying more than 90 days)
	Registration with the relevant authority in Lausanne or other municipality.
	You need to bring with you:
	- Valid passport or ID
	- Birth certificate (translated into French, German, Italian or English)
	- Marriage certificate, if you are married (translated as mentioned above)
	- Invitation letter or employment contract from UNIL
	- Photos in passport size (needed for residence permit)
	- Rent contract/ sublease contract
	- Official announcement of arrival:
	For EU/EFTA nationalsFor Non-EU citizens
Step 2	Take out <u>health insurance</u> (LAMAL). Health insurance is mandatory in Switzerland. You must obtain health insurance no later than three months after you arrive. It will be effective from the date of your registration within your municipality.
	For any exemption's requests, please contact us.
Step 3	Contract other insurances (e.g. liability insurance)
Step 4	<u>Open</u> a bank account. Don't forget to bring with you the following documents:
	- Your residence certificate (delivered by the immigration office or municipality) or residence permit if you already have it
	- Your passport or ID
	- Invitation letter or employment contract from UNIL
Step 5	Buy your travel pass for public transport in Lausanne (check out at <u>TL website</u> )
