Master of Law (MLaw) in judicial careers

GENERAL OUTLINE

Objectives

The Master of Law in Judicial Careers is aimed at students who wish to work in the judicial professions, for example as a judge, prosecutor, barrister, registrar, mediator, arbitrator or lawyer working in the legal department of a business, legal protection insurance company or administrative authority. It takes a combined theoretical and practical approach and enables students to develop in-depth skills in trials and disputes in criminal, civil and administrative cases, based on a unique multidisciplinary approach.

Skills development

The Master of Law in Judicial Careers develops the following skills:

- the acquisition of cross-cutting, interdisciplinary skills specific to the Faculty's three Schools (the School of Law, the School of Criminal Justice and the Graduate Institute of Public Administration) linked to judicial practice, managing a court, communication, interpreting evidence and the rights of victims and injured parties;
- the development of an understanding of judicial practice through classes and workshops in relation to civil law (particularly family law, adult and child protection, inheritance and enforcement), administrative law (particularly the law on foreign nationals) and criminal law (such as the

law on the execution of sentences and forensic expertise in criminal matters)

- the acquisition of practical experience through a one-month internship in a court, judicial office, prosecutor's office, law firm or any other legal department, including a write-up of their experience (instead of a Master's dissertation)

Career prospects

The Master of Law in Judicial Careers is an advantage for securing an internship as a lawyer or as a registrar in a judicial office or prosecutor's office. From a longer-term perspective, it offers high-quality training for those who wish to work in the following professions:

- judge, prosecutor, arbitrator or registrar in a court, judicial office or prosecutor's office
- independent barrister or partner in a law firm
- mediator
- lawyer in the legal department of a business, legal protection insurance company or administrative authority

EDUCATIONAL CONTENT

Description

The Master of Law in Judicial Careers requires 120 ECTS credits, broken down as follows:

- Module 1 – compulsory courses
30 ECTS credits
- Module 2 – compulsory courses
50 ECTS credits
- Module 3 – block courses
6 ECTS credits
- Module 4 – optional courses
15 ECTS credits
- Module 5 – one-month internship and report or Master's thesis and viva
19 ECTS credits

Module 1: Compulsory courses: total 30 ECTS credits

- Organisation and Operation of the Judicial System
- Advanced Family Law

Module 3 – Block courses: total 6 ECTS credits

- Workshop on the Justice of the Peace (bankruptcy and debt, successions, inheritance, child and adult protection, placement in care)
- Management tools and digitisation of justice
- MOOC (Massive Open Online Course) topic: Forensic science in court: a reliable witness? Other questions of interpretation

Module 4 – Optional courses: total 15 ECTS credits

Module 4 offers students a free choice of other university Master's level classes from another course offered in the Faculty, provided they are delivered by the Swiss Graduate School of Public Administration (IDHEAP), the School of Law or the School of Criminal Justice, for 15 ECTS credits.

Unlisted courses - 6 ECTS credits

Module 4 can include university Master's level classes not listed in the Master of Law in Judicial Careers study plan and can be taken in another faculty or another university or university institute, for 6 ECTS credits. The request must be submitted to the head of the School of Law within three weeks of the start of classes in the semester in which the student wishes to take the classes concerned.

Module 5 – Internship or thesis: total 19 ECTS credits

Internship (including report) or Master's thesis

PRACTICAL INFORMATION

Admission requirements

The candidate must be a holder of a Bachelor of Law from a Swiss university or, subject to a refresher course, of a Bachelor of Science in Forensic Science. Another degree or university title may be judged to be equivalent and give admission to this Master's degree course, with or without further conditions. The School of Law is competent for the final decision on equivalence (administration.droit@unil.ch), subject to the candidate's formal admissibility to the Master's degree course.

Enrolment and final date

Applications must be submitted to the Admissions Department (www.unil.ch/immat) before 30 April.
